- .gov are government websites and usually good sources for statistical information
- .org are typically non-profit organizations often set up as a public service.

Be on the lookout for political agendas and biases.

Wikipedia is not a credible source because anyone can edit it at any time.

We are out there every day in the American streets reaching more and more people everyday...Our children have no chance to make it now if we don't stick together and fight for WHITE PEOPLES RIGHTS. The Blacks have the NAACP the Mexicans La Raza and the Jews have the ADL. We whites all across America have the Ku Klux Klan; fighting for a Brighter Whiter America" (KKK Knights). The KKK clearly thinks that it is making a difference in the world for white people. They believe that their violence and hate creates a society in which white people are the most significant and powerful people in the world.On the same current website, the KKK openly advertises violence toward a white woman and a white man. "Beware of these two have been banished from the loyal white knights. It has come to our attention they have a half breed black

teen. Also for unklannish behavior toward many officers in the LWK.. Both of them are race traitors. They have been caught red handed taking money from 4 states. which was to go to the Christmas Stocking drive for the klan kids. Brad Brown and Linda Michelle Brogdon Brown 2106 Maple Ave , Waco , TX 76707" (KKK Knights). It is hard to believe that the KKK is still openly exploiting and endangering people, even its own members. Although there is more police and political control over groups such as the KKK now, it is questionable how powerful the Klan still may be. Continuing to watch over and police groups like the KKK is important to maintaining the equality established by the civil rights act and other legal actions made to stop such violent behaviors.
